RMU is upgrading our operating software to better serve our customers more effectively and efficiently. The next phase will begin soon! From April 2nd until April 8th, we will be unable to process any electronic payments, which includes any credit card payments in person, online, or over-the-phone. During those dates, we can only accept payments by cash or check. If you have automatic payments scheduled through our online payment portal for those dates, they will not be processed. Please reschedule your payments to avoid those dates. We apologize in advance for the inconvenience. The Customer Service portion of the new software is anticipated to go live April 8, 2024.

### PLANNING A SPRING PROJECT? IF IT CALLS FOR DIGGING, CALL MISSOURI 811.

Are you planting a tree? Installing a mailbox? Building a fence or deck? Or are you finally starting that garden that you've been dreaming of? Remember to contact Missouri 811!

For digging projects big or small, you need to contact Missouri 811 at least 3 working days before you start digging to avoid hitting an underground utility line. It's free, it's simple and it's the law. Missouri 811 notifies its member utility companies to mark their underground facilities where you plan to dig. Missouri 811 does not locate or mark underground facilities. This is done by the member utility companies or their locators.

Safe digging is everyone's responsibility. Failure to dig safely can result in costly damages and repairs, loss of essential utility services, and even serious injuries to you or your neighbors.

## LEAD SERVICE LINE INVENTORY

As required by recent US EPA regulations, RMU is undertaking an inventory of water service lines. The purpose of this review is for all water utilities to better understand if, and where there are lead water service lines that provide the connection from RMU's water distribution system to the customer's location. In Rolla the customer owns the water service line and RMU is responsible for maintenance of that portion in street right-of-way, but this review is required to consider the entire service line up to the point where it enters the structure. In order to complete this review, the work will be done by RMU and contractors for RMU. We will also be in contact with customers to request information about their service line where it enters the building.
